This is a list of individuals that are authorized to practice before the Tribal Court of the Fort McDowell Yavapai Nation pursuant to Section 1-25 of the Fort McDowell Law and Order Code.

The Tribal Court does **NOT** recommend or suggest one advocate or attorney over any other. **Selection of an advocate or attorney is a personal choice.**

The Tribal Court in no manner guarantees that these individuals are accepting cases at this time or makes any representation or guarantee about the quality of legal services each individual might provide.

The people listed below are those authorized to practice before the Tribal Court, but any attorney in good standing who is licensed to practice law in the United States may be able to represent you, if you so choose to have a licensed attorney represent you and they are not listed on this list, they can apply by filing an application to practice with the tribal court (applications can be obtained through the clerk's office)

A Tribal Advocate is an Indian person who is **NOT** a licensed attorney but who believes he/she has adequate knowledge of tribal law to defend a person against criminal or civil complaints. **Any person who retains the services of a non-attorney tribal advocate does so at his/her own risk regarding the competence of the advocate.**
