

**FORT MCDOWELL YAVAPAI NATION**  
**32nd Anniversary Orme Dam Victory Days**  
**Food / Arts & Crafts Vendor Application**  
**November 15th, 16th, & 17th, 2013**

The Vendor, \_\_\_\_\_, hereby agrees to the terms and conditions of this Vendor Agreement (“Agreement”) for the Fort McDowell Yavapai Nation (“Nation”) Orme Dam Victory Days. The term of this Agreement shall begin on November 15, 2013 and expire on November 17, 2013.

**I. Responsibilities of Food/Arts & Crafts Vendors**

- A. For Food Vendors Only: Food vendors and all individuals assisting such vendors must have valid food handler’s permits and that all such permits must be displayed at the vendor space/booth at all times for the public to view.
- B. Registration area will be open from 10:00 a.m. – 5:00 p.m. on Friday, November 15, 2013 for set up (1 day only). Vendor must be in booth by 5:00 p.m. on Friday, 11:00 a.m. on Saturday & Sunday and be ready for business and remain open until the conclusion of the event.
- C. Vendor is responsible for covering and taping down all electrical cords, securing awnings and tents, and securing other coverings or equipment.
- D. Vendor is responsible for supplying all booth items, including appropriate tables or counters space, hand washing buckets, water, electric, fire extinguishers and appropriate signage. Signage will include the name of the organization, food items for sale, and prices.
- E. All generators need to be properly grounded.
- F. Vendor shall maintain a sanitary and clean booth at all times.
- G. Vendor shall be responsible for his/her own supplies, merchandises, materials, tables, signs, equipment and all other property.

**II. Responsibilities of the Fort McDowell Yavapai Nation**

- A. The Nation will provide Vendor with the following:
  - 1. Food/Arts & Craft vendor space 10 feet x 20 feet; any additional space needed will be an additional charge.
  - 2. Garbage dumpsters in the vicinity
- B. The Nation will provide limited vendor parking available on a first-come, first-served basis.

**III. Fees**

- A. Vendor agrees to pay \$100 per day for vending booth. No refunds shall be provided after November 14, 2013.
- B. Vendor agrees to pay \$75 per day for vending booth located at the Rodeo Grounds.
- C. Applications will only be valid if they are filled completely and accompanied by a cashier’s check or money order payable to the: “Fort McDowell Yavapai Nation.”

**IV. Adherence to Policy**

Vendor agrees to abide by the laws of the Fort McDowell Yavapai Nation and applicable laws. Failure to abide by such laws may result in termination of this Agreement and penalties and sanctions pursuant to the Nation’s law and applicable laws.

## V. Choice of Law and Forum

The laws of the Fort McDowell Yavapai Nation shall govern this Agreement. The Tribal Court of the Fort McDowell Yavapai Nation shall have exclusive jurisdiction over any claim arising from this Agreement.

## VI. Indemnification Agreement

Vendor hereby agrees to indemnify and hold harmless the Nation, its officers, agents and employees from any and all claims, demands, losses, or damages, including attorney's fees, which may arise in any manner from the Vendor's activities or presence on Nation's property and jurisdiction as authorized by this Agreement. This release and indemnification obligation includes, but is not limited to, claims made by the Vendor, its agents, or employees.
